This Covenant is for the sole benefit of Weber County and shall not be assigned by the Grantee to any other party.

If this Covenant is breached or violated in any way, Weber County may at its option, require immediate termination of the offense. Weber County hereby reserves all rights of enforcement and other remedies available at law.
